Flathead Watershed Sourcebook

The colorful, 260-page *Flathead Watershed Sourcebook: A Guide to an Extraordinary Place* is now available to the public.

Viewed from a bioregional perspective, the book discusses the many people and systems that make up the Flathead Watershed—one of the most biologically intact ecosystems in North America.

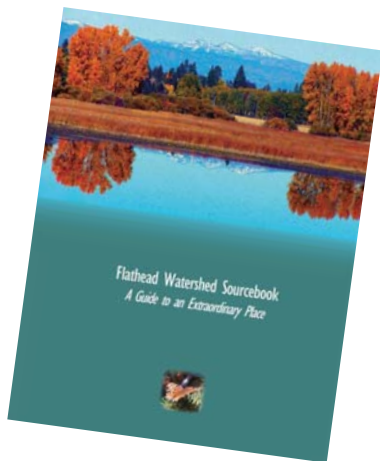
The book – and its companion website www.flatheadwatershed.org– where the entire book is displayed, is the product of the Flathead Community of Resource Educators (CORE). It was sponsored by: the Crown of the Continent Ecosystem Education Consortium, Flathead Audubon, Flathead Basin Commission, Flathead Conservation District, Flathead Lakers, Flathead National Forest, and the Whitefish Lake Institute.

The book weaves science and art, nature and human nature into an appealing and informative publication. It describes the Flathead Watershed including its natural history, climate, biodiversity, cultural history, town profiles, water bodies, water usage and quality, influences and protections, land ownership and management, agricultural

production, economics, and watershed conservation and education resources.

More specifically the book includes detailed information on:

- An overview of the human history, both native and European, cultures of the Flathead.
- Descriptions of the unique natural history of the region's geology and plant and animal life.
- Explanation of land ownership patterns, land management and resource management.
- Details of the economy, food and natural resource production. (*continued on page 4*)

Water Steward Remembered

Bill Leonard passed away peacefully at his home in Whitefish on October 21, 2010 with his family by his side.

Bill served as WLI board member from 2007 until his death. Throughout his life, Bill loved the outdoors which passed from his father and he, in turn, passed onto his sons. Hunting, fishing and camping were Bill's passions.

Bill retired from three careers-the Army, the railroad, and the Midwest Assistance Program, a non-profit organization that travels to rural communities and helps them set up and finance water and sewer systems.

In 1982, Bill spearheaded community efforts to establish the Whitefish County Water and Sewer District, the public entity that sponsors water quality projects for the area. Voters approved creating the district with a 4-1 vote.

Two years later, Bill helped get funding for the first water quality study of Whitefish Lake. For Bill, the need for solid science and research were the driving force behind the project.

Bill's push for research on Whitefish Lake stemmed from his own personal observations. He was concerned that the lake was degrading before his eyes. He recalled crystal-clear waters years ago with colored rocks visible in 8-10 feet deep, that started fading to gray-green scum. Bill felt that the lake was going downhill and he saw the need for establishing a baseline.

Bill advocated for a second water quality assessment, which was completed in 2003. His tireless efforts behind the scenes, writing and administering grants and serving on the Whitefish Water and Sewer District since its inception, and serving on the WLI board, made him a true water quality steward for the community. His passion for the resource and leadership will truly be missed.

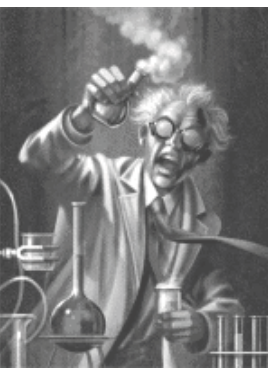

WLI Job Opening- Environmental Scientist

The Whitefish Lake Institute in partnership with Montana FWP, and the Flathead Basin Commission is seeking a full-time environmental scientist. This position will have dual responsibilities with 2/3 time as coordinator of the Northwest Montana Lakes Volunteer Network and 1/3 time as WLI staff scientist.



The position is responsible for all aspects of coordinating the Northwest Montana Lakes Volunteer Monitoring Network (NWMTLVN) (2/3 time). In 2010, NWMTLVN was developed to merge two existing programs; FBC Volunteer Monitoring Program and the WLI/FWP Whitefish to Eureka Lake Volunteer Monitoring Program. Position will coordinate and train local volunteer monitors, collect field data, administer website and manage database, interpret data and supply an annual program report. Position will also research and write small grants.

The position will also be the lead field scientist for WLI (1/3 time). Position will collect field data for Whitefish Lake tributaries, Whitefish Lake, Tally Lake, Blanchard Lake, Swan Lake, and atmospheric bulk loading. Position will work with WLI ED to interpret and report data to the public. Position will also be required to fulfill the many miscellaneous tasks associated with the operations of a small non-profit corporation.

A bachelor's degree with a major in the environmental sciences or a related field, an understanding of aquatic ecosystems, and field experience in water quality data collection is desired. Excellent communication skills and computer proficiency are required.

Pontoon Boat Donated to WLI

WLI recently acquired a pontoon boat thanks to an anonymous donation. The pontoon boat will replace WLI's original pontoon boat donated by Bill and Ruth Leonard in 2005. The old boat was perfect for our research on the lake but over the course of five field seasons of use, it was in constant need of maintenance including multiple welds to keep the pontoons water tight. The new pontoon boat is 24 feet, two feet longer than the old boat.

The E-tech motor, partially funded via a Whitefish Community Foundation Grant will be swapped from the old boat to the new boat thanks to the generosity of Jim Berry's expertise. At that point, Chris Ruffatto will engage the help of industrial arts students from the high school to retrofit the new boat with the needed specialized infrastructure that we had on the old boat.

The new boat also allows for expanded seating that will enhance the lake experience during our outings with Whitefish High School Project FEEFLOW students, during Whitefish School District Teacher In-Service Training Sessions, and for outings with other small groups.

The book was written by Lori Curtis, of Bigfork, as part of her post-graduate studies.
